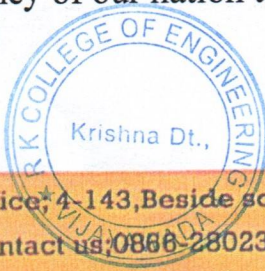

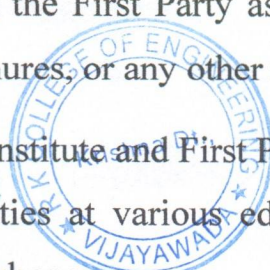
OBJECTIVE:


